

### **Topics of Focus**



#### The Pediatricians Accelerate Childhood Therapies Act of 2023 (S. 2345 & H.R. 4714)

#### OVERVIEW

Without a healthy and sustained commitment to developing the next generation of pediatric-focused researchers – particularly physician-scientists who bridge the research lab and clinical care – the pace of innovation will be slowed. The result will be fewer research breakthroughs and more diseases and conditions lacking disease-treatments, therapies, or cures. While Congress and the National Institutes of Health (NIH) have recognized the challenges associated with developing early-career researchers, a number of barriers remain, particularly in the field of pediatrics.

Key pediatric stakeholders and experts continue to underscore the urgency of addressing these challenges. Most recently, in September 2023, the National Academies of Science, Engineering, and Medicine (NASEM) released a much-anticipated <u>report</u>, entitled *"The Future Pediatric Subspecialty Physician Workforce: Meeting the needs of Infants, Children, and Adolescents."* Among its many findings, the study found that existing NIH career development funding levels are insufficient and that pediatric physician-scientists specifically are in need for targeted support to empower pediatric research. As a policy remedy, the study recommended that NIH should "increase the number of career development grants in pediatrics, particularly institutional training awards." This recommendation and complementary proposals directly justify the need for Congress to enact the Pediatricians Accelerate Childhood Therapies Act (S. 2345 & HR. 4714) to support pediatric researchers and address the unique challenges they face. •Proposes new trans-NIH funding mechanism for pediatric research training targeted at early-career researchers and diversity

•Formalizes under law the Trans-NIH Pediatric Research Consortium (N-PeRC) that has been established at NIH to coordinate pediatric research activities across institutes and centers
